Notes from the June 15th Neighborhood Meeting

Representatives from Harvard University were our guests at the June meeting to update residents on development. Those present included Tom Lucey, Lois Stanley, Mary Power, and Charlie Connor, representative for FAS Construction Mitigation. Tom Lucey presented updates on FAS and Harvard Law development. These updates are covered in the Harvard Development update on page 1.

Tom also answered questions posed by a group of concerned Agassiz citizens who had met a week earlier to discuss Harvard development. Questions below are followed by Tom's answers.

North Yard

1. What is the time frame?

In the next 3 months, work will be done on LISE, as well as some utility upgrade work, which may change some pedestrian walkways in the Museum Street/Divinity Ave areas.

2. When will the garage be done? What will be put on top of it in the year following completion?

The garage is scheduled to be finished in December 2004. After a public process, the NorthWest building will go on top of it.

3. When will the fence be coming down? Are there further thoughts about the idea of a small park promised for the Hammond/Gorham area?

The fence will remain through the construction of the NorthWest building, until 2007. When Palfrey House is done, the fence will accommodate it.

4. When will the concrete wall along Gorham Street be removed? Will the park be at sidewalk level? Will there be sidewalk on Gorham Street?

Harvard Development Update

Harvard University North Yard update presented at the ANC Meeting of June 15, 2004

(Updated in August for the September edition
 of The Whistler)

It is my pleasure to provide you with a brief update of activities around the Harvard University's North Yard as well as to reaffirm our commitment to keep the line of communications open with you.

In terms of Faculty of Arts and Science's (FAS) projects, updates include:

The Laboratory for Interface Science and Engineering (LISE) - LISE is the facility that will be located adjacent to the McKay Lab at the south end of Oxford Street. It will be used by the scientists in several departments including Physics, the Division of Engineering and Applied Sciences, Chemistry, and Biology for research in nanoscale and mesoscale science. Harvard presented

The wall will not be removed until 2007, when the NorthWest building is scheduled for completion.

5. Will the asphalt around the greenhouses be removed when other parking is available?

Currently this asphalt is part of the NorthWest construction site.

6. Where is the vehicle exit/entrance to the garage, and the ventilation shafts? How will Harvard prevent noise and pollution from the garage entrance/exit and ventilation shafts from going toward the neighborhood, especially to the abutters on Hammond and Oxford Streets? How will Harvard handle ventilation from the garage during and after construction? Will the garage be in use during the construction of the NorthWest Building?

Some of these questions can't quite be answered yet as the work is still in design stages. Acoustical and wind tunnel studies will help predict/avoid noise and pollution issues. The garage will be in use during NorthWest construction.

7. Please explain the latest thinking and present updated plans for the NorthWest Building. What will the site be? Are there still plans for a "Pavilion?"

[The latest information on the NorthWest building is included in the Harvard Development article on page 1.] Architect design for the pavilion is not yet finalized.

8. When will they pull the permit for the NorthWest Building?

The permit will not be pulled until after there is a community process.

9. What are the landscaping plans along 60 Oxford Street, Palfrey House and the Hammond Street Edge? Landscaping plans are not yet complete; Harvard is taking input on this issue from the community.

10. What are the near-term and long-term plans for the Divinity School parking lot and nearby parking lots? Part of the MOU development would be on the asphalt.

Law School Development

1. What is the time frame?

An architectural and planning firm still has not been selected for this development. Harvard hopes to choose one in the summer of 2004. In the first 6 months, they will redefine programming; then comes site design, fol-

lowed by building design.

2. Is it true that Harvard plans to tear down the Everett Street Garage and Wyeth Dorm?

Yes, Harvard does intend to tear down the Everett Street Garage. There are no final plans to tear down Wyeth but it is the best site for the Law School development.

3. When are they tearing down the garage? If this will happen before the other garage is completed, where will cars park in the meantime?

The garage will not be torn down until the new garage is finished and in use.

4. Will they make part of Everett a 2-way street?

This issue still needs to be discussed with the community and the City.

5. Will there be space for commercial development on the first floor of new Law School buildings?

Harvard is currently considering the neighborhood's feelings on the Bence Site between Everett and Wendell. They aren't currently contemplating retail south of Everett.

6. We've heard rumors about moving the two Victorian houses on Mass Ave. What are your current thoughts about possible locations for these houses?

Some Neighborhood 9 residents have suggested moving the Victorian houses to the North Hall site. Charles Sullivan of the Cambridge Historical Society believes that the houses are connected to Mass Ave and should stay there. Harvard has not yet reached any decision regarding the houses.

A resident proposed the following suggestion for dealing with construction mitigation:

1. Resident calls construction mitigation number.
2. If problem not resolved, resident calls Tom Lucey.
3. If problem still not resolved, resident contacts Amy King, ANC Community Liaison, and ad hoc committees set up as needed to deal with these problems.

Lesley University Update

Lesley University is currently in the process of sending out a RFP to find an architect who will renovate and enlarge White Hall, the large residence hall that backs up to Oxford Street. They want to either build up or fill in toward the amphitheater. Lesley expects to have some proposals in September, so they will report at the September 21st neighborhood meeting. At that point they will discuss a public process. Construction will be done over the course of two summers -- the university hopes to start construction in May 2005 and open in Fall 2006.

Beacon Street Drainage Improvements Project

Update – August 2004

What's been done to date...

- * The two underground Stormwater Storage Tanks have been completely installed and backfilled.
- * Grading and compacting the road sub-base in the trench over the Tanks in preparation for paving is done.
- * Force main has been installed.

What's happening now...

- * Relocation of 6-inch water main and water service hook-ups is ongoing.
- * Installation of mechanical/electrical components and control panel is ongoing.

What's to come...

- * Grinding and overlay paving of Beacon Street will be completed.
- * Curb and sidewalk restoration will be completed.
- * Completion of catch basin installation.
- * Activation of system and pump stations.
- * Installation of drainage training berms* (*berm: a raised, asphalt pavement - a few inches high, gradually sloped - that directs surface stormwater to the curb line and into the catch basins and helps prevent surface water from running down the side streets from Beacon Street. This is a stormwater management technique used to help minimize surface flooding during heavy rainstorms). Berms will be placed on Forest, Prentiss, Eustis, Sacramento and Museum Streets.
- * Complete punch list items and site restoration.

Be a Good Neighbor: Pick Up After Your Dog!

The City of Cambridge has a Pooper Scooper law that requires dog owners to carry means of removal and remove any feces left by their dog. It is illegal to leave pet waste in public areas, or on private areas you don't own or occupy, and will result in a \$50.00 fine for repeat offenders.

Why?

- * Pet waste contributes to pollutants in the Charles River and Little River/Alewife Brook.
- * Waste dumped or washed into stormwater drains is carried directly to rivers.
- * Pet waste can carry viruses and bacteria that are harmful to humans.
- * Pet waste contains nitrogen and phosphorus nutrients that accelerate growth of damaging algae and aquatic weeds.
- * Pet waste is damaging to trees.
- * Cleanup of parks ruined by pet waste costs you more in taxes. Pet waste left by owners could lead to pets being banned from parks and other areas.
- * Keeping public areas clean will improve neighbor relations, assure your pet will be more welcome in the neighborhood, and allow everyone to enjoy open space.

The next time you take your dog out for a walk, bring a plastic bag or scooper to pick up after him/her. You will be promoting better relationships with neighbors, improving the environment, saving money, and adhering to the law.

this project to neighbors multiple times including two presentations at the Agassiz Neighborhood Council (ANC), three meetings to discuss construction impacts, and displays at the Sacramento Street Gallery and the Baldwin School. Site prep began in mid-April and construction of the foundation will begin in September. Construction will continue through the fall of 2006.

Palfrey House -- The Palfrey House has been moved twice in the past 18 months -- first to make room for construction of the Oxford Street Parking Facility and second to place it near its final location above the Parking Facility. Review by the Cambridge Historic Commission was completed last fall. Renovation is now underway on both the interior and exterior of the house. FAS will occupy Palfrey House for office space beginning in September 2004.

NorthWest Building -- Currently under design by Craig Hartman of Skidmore, Owings, & Merrill, the NorthWest building will be a 436,000 gsf structure (approximately 1/2 underground) to be located above and adjacent to the Oxford Street Parking Facility. To date, Harvard has had four meetings with neighbors who provided the architects with input, most recently on June 17. We have scheduled time at the September 21 meeting of the ANC to discuss this project. The city approval process (a Board of Zoning Appeal variance is required) is expected to take place later this year. It is hoped that construction will begin in early 2005 and continue until September of 2007.

Utility Work --Some utility upgrade work in the north yard is now underway. For the summer months and continuing through the fall, the Andover Hall and Museum of Comparative Zoology (MCZ) lots were the sites of construction activity. Pedestrian pathways may be impacted for a short time in the fall. Science Center – The work is completed!

Other updates relate to the Harvard Law School:


As you may know, in 2002 the Harvard Law School (HLS) began a process to assess the potential of its current site to accommodate future space needs as well as to understand community and city issues regarding possible development.

One of the findings of this process was that if HLS could replace the existing Everett Street parking garage with an underground parking structure and relocate the two existing Massachusetts Avenue wood frame houses, there is a good chance its space needs could be accommodated in Cambridge.

In August, HLS chose Robert A.M. Stern Architects as the principal design firm to prepare a planning framework for the Law School campus and to provide the architectural design for the initial development on the school's northwest corner. Currently, Robert A. M. Stern Architects is conducting programming studies that will eventually lead to site design and building design. Of course during this planning process, we will be working with the community and city to shape an agreement on the overall development plan.

Also, Cambridge City Manager appointed three people from Agassiz (Joel Bard, Adriane Bishko, and Ellen Friedman) to sit on the Agassiz-Neighborhood Nine Working Committee that will consist of representatives from Neighborhood Nine, Agassiz, the City of Cambridge, and Harvard University. This Working Committee is an element of the ongoing consultation process between Harvard/HLS and the Agassiz Community as envisioned in the recently adopted Memorandum of Understanding. The first meeting of this group took place on the 24th of June and the next meeting is scheduled for September.

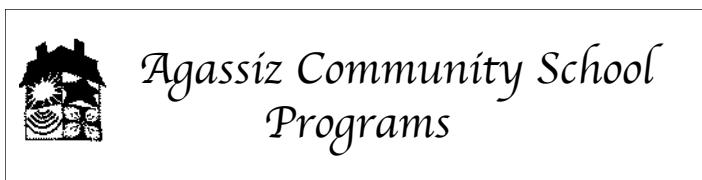
