AGASSIZ NEIGHBORHOOD COUNCIL NEWS

Minutes from the Nov. 10th meeting of the Neighborhood Council:

At the Nov. 10th meeting, the first item of business discussed was the question of a raise for the ning person at the Agassiz Community Center. It was decided to vote on this issue at the next meeting of the Council Executive Committee.

A letter of appreciation from the Neighborhood Council for the city-wide planning of Halloween parties, siting cooperation between all City services and agencies, and addressed to Mayor Vellucci and other members of the City Council, was read and approved by the Council (and was mailed following the meeting).

Ned Casey came from the City of Cambridge Cable T.V. Office and gave an informative presentation on the possible development of a municipally owned and operated Cable T.V. system in Cambridge. A short film was shown and brochures passed out.

Next, the topic of traffic safety on Oxford Street was discussed. The major "dangerous areas" seem to be the end of Oxford Street at Beacon Street, the intersection of Oxford and Forest Sts., and the stretch of Oxford Street in front of the school. The ideal solutions to these problems would be greater enforcement of speed limits and parking regulations at intersections as well as blinking slow-down lights and signs in the vicinity of the school. Donna Treece agreed to contact the Traffic and Police Departments about these problems and report back to the Council at the December meeting.

Jennifer Page, from Lesley College, then brought up the amendment, being proposed by David Sullivan (of the Cambridge City Council), to close the "loophole" in the Institutional Expansion Ordinance which allows colleges and universities to own "affiliate housing" in neighborhood areas outside the institutional expansion limits required by the Ordinance. (Affiliate housing is housing for faculty or other university employees.) The Council decided not to take a stand either in favor or not in favor of this amendment.

A representative from the Senior Citizens' Mutual Aid Group at the North Congregational Church announced that there would be a hearing with the MBTA on Sunday, Nov. 21 at the church to seek better bus service along Mass. Ave. between Harvard Square and the Arlington line. (Results of the hearing will be reported on at the December Council Meeting).

GARFIELD STREET/MASS. AVE. MTA LOT

If you've been in the Agassiz neighborhood for more than a couple of weeks, you've noticed that we are host to a sizeable MBTA construction-staging operation at the corner of Mass. Ave. and Garfield Street. If you've been in the neighborhood for a few years, you might remember that the original MBTA Red Line plans did not call for this kind of activity for that site. The MBTA had only anticipated using a corner of the lot for a vent shaft/emergency exit for the subway tunnel. Instead, the T took the lot and demolished the existing house in order to use the site for construction purposes.

The MBTA now owns that lot. Because this had not been part of their plans, it is reasonable to assume that they do not intend to keep it. Cambridge's Community Development Department (CDD) is operating under the same assumption. Given the above history, the views of the Agassiz neighborhood on the future of the lot could be very influential in determining what use should be made of it. The Cambridge CDD is encouraging Agassiz to play an active role in planning for this site.

At the next Council meeting, Weds., December 8th at 8:00 p.m. in the Agassiz School library, we will begin to discuss this lot. This lot represents an important opportunity for Agassiz residents to be involved in a major decision affecting our neighborhood.

CAMBRIDGE COUNCIL ON AGING EXPANDS OUTREACH SERVICES

The Council on Aging is the division of the Cambridge Department of Human Services which handles basic services for elderly residents of Cambridge and serves as official advocate for their needs. Among those services offered by the Council are: information about community services; help with jobs, housing and transportation; a monthly newsletter (NEWS-LINES); telephone reassurance; small neighborhood groups (Mutual Aid); and community outreach, including home visits.

The Council on Aging is now in the process of expanding its outreach services and is seeking volunteers who are interested in doing community outreach and home visiting

It was helpful to learn about the experience of a community in attempting to control development within its boundaries, and Bob's information and comments were much appreciated.

It was decided that the Planning Group should begin to direct itself to reviewing the existing situation on Mass. Ave. and possibilities for development there that would be consistent with community desires. Special attention will be focused on the MBTA site on Mass. Ave. and Garfield St. The next meeting will be on Weds., December 15 at 8:00 in the Community Center. Please plan to attend if you have concerns or suggestions about the future of Mass. Ave.

RESIDENT PARKING STICKER INFO

Permits will be issued by neighborhood this year. The dates stickers will be issued to Agassiz School Area residents will be December 13-December 17. Other rules and schedules are:

1. You must have your Mass. registration with you to get a sticker.
2. Your Mass. Excise Tax must be paid.
3. If you are applying for visitor permits, you must have a current utility or telephone bill with you.
4. Office hours are Mon-Fri, 8:30 am to 4:30 pm. The Department will also be open on Saturdays from 9:00 am to 4:30 pm on Dec. 4, 11, and 18.
5. The cost of stickers and permits is \$3.00. There is no charge for people over 65 with an ID card.
