



NOTES FROM THE FEBRUARY 13 BNC MEETING

Mass Ave Planning Study



Drew Kane, Senior City Planner from Cambridge's Community Development Department (CDD), attended the February 13th Baldwin Neighborhood Council meeting to introduce the Mass Ave Planning Study (MAPS) project. This is a long-range planning study looking at the two-mile stretch of Massachusetts Avenue between Cambridge Common and Alewife Brook Parkway. This effort is intended to help planning for the next 15 years in areas of housing density and affordability, local and small business support, and enhancing sidewalks and public spaces.

Alongside Mr. Kane, the project is being led by Director of Community Planning Melissa Peters, partners across other city departments, and consultants in planning and urban design, architecture, and real estate and housing.

The project also involves a working group consisting of homeowners, renters, students, business owners, representatives from neighborhood groups, institutional representatives, and professionals with relevant backgrounds in urban design, architecture, and commercial property development.

"We wanted to get a broad spectrum of people," Mr. Kane said.

The working group's role is to reflect community interests, provide feedback, monitor progress, engage other community members, and help establish goals. Mr. Kane said the group plans to meet regularly.

The planning study will be divided into four rounds over 18 months. After the first round

kicking off the project, the team will first focus on the section of Mass Ave south of Porter Square. From mid-summer through the end of the year, they will then focus on the northern section of Mass Ave. The fourth round will close the project with a public event to reveal and celebrate the final plan.

The team will also host community meetings throughout the four rounds, which help meet the goal of a "more equitable process," as Mr. Kane explained.

"We are trying to do as much outreach and engagement as possible," he said.

Mr. Kane distinguished this project from the other concurrent city initiatives along Mass Ave: Partial Construction for the planning and design of separated bike lanes, Impact Study of assessing the new bike lanes' economic impact, and Combined Sewer and Overflow Mitigation exploring green stormwater infrastructure mitigation measures to prevent combined sewer overflow events.

"Urban design is very much part of this project," Mr. Kane explained.

Q&A

- Q: "What are the most significant lessons you and your team learned from the process to install protected bike lanes on parts of Mass Ave and how does it relate to this process?"
- A: "For the separated bike lanes on Cambridge Street, we were able to receive input and concerns, such as interest in shortening the distance between crossings, and accommodating mobility issues and summarize the issues in an engagement report.. For this process, we want to take all voices into consideration. However, a lot of the work with respect to

- transportation and bicycle planning has been done already, but it will be referenced in our planning process."
- Q: "How do you see the future of the motorized vehicle and how does that fit into this planning?"
- A: "The city encourages reducing the reliance on personal automobiles, but I think considering people who use their own vehicles is part of our near term planning, and we need to be able to accommodate that."
- Q: "What's going to happen to the median strip?"
- A: "Historically it was made to reduce pedestrian crossings and facilitate the flow of traffic. The Mass Ave Partial Construction Project is looking to remove those to retain some on-street parking and loading, while making street safety improvements."
- Q: "At one point in this neighborhood, the sewer and stormwater systems were separated. How does that interact with the plan you mentioned?"
- A: "The sewer and stormwater system in this neighborhood does not relate to the planning in North Cambridge at the Alewife Brook."
- **Q:** "How does this project intersect with the affordable housing overlay?"
- A: "We want to prioritize the development of affordable housing. Right now, Mass Ave is a maze of different zoning districts that all involve different heights and densities. We want to establish a bit of consistency of zoning along Mass Ave, which will involve increasing height and density. It will be a matter of community input and feedback. We will consider the influence of the Affordable Housing Overlay as we plan for Mass Ave, but those are separate regulations from our work here."
- Q: "With Harvard University moving its science functions to Allston-Brighton, who are you working with from Harvard and what are

- their use plans for the buildings that will be vacated?"
- A: "We did speak to the Harvard planning team; however, we did not discuss what will become of the buildings that will be vacated. I don't know enough about their space planning and occupancy plans. We also weren't told anything by that department that would suggest any major changes. There will be opportunities to ask questions in the future and a member of the working group is part of the Harvard campus planning team. We'll be in touch with them throughout the course of the project."



Herbwell Cannabis Update

Arish Halani, owner of Herbwell Cannabis at 1686 Massachusetts Avenue, joined the February 13th meeting to share another educational presentation on cannabis and re-introduce his sister Sareena Halani, Operations Director.

The store has now been open for a few months and had its grand opening on February 10th. Ms. Halani presented the different effects of cannabis and explained how they categorize products by their intended or likely effects.

Herbwell has also created a consumer guide of these effects that are available physically in-store or as a digital download.

Q&A

- Q: "There is another cannabis shop opening a few blocks away. What methods will you use to distinguish yourself from the competition?"
- A: "The primary differentiating factor is that we

- have effectively categorized every product into an effect range so we can answer how each product will affect you, and categorize it in a way that is easy for the consumer to understand." - AH
- A: "We are very focused on consumer experience and want to take on the diligence of a pharmacy when selling anything." - SH
- A: "There are a handful of permits in Porter Square that are not open yet. None of these stores have begun their construction process, so we don't see them opening any time soon."

- Q: "Do you have any interactions with communities impacted by the war on drugs and is that factored into your hiring?"
- A: "We have a contract with the city that says we will hire, and have hired, a certain percentage of people representing different identities.

 [Ours] is also a minority-owned dispensary permit. We also have another contract with the state requiring us to identify a member of the community that has been impacted by the war on drugs and have some working relationship with them. We have identified a candidate and are working with them to help them open up their own store in Boston." AH
- **Q**: "How does your door work?"
- A: "As per state regulation, you cannot see any cannabis product from the street. We have a vestibule that protects the dispensary merchandise, so you first walk into a check in area where your ID is verified by an employee and scanned by a statewide system. You are buzzed in once your ID has been verified."

- Q: "What's the difference between chewing or dissolving in terms of absorption rates?"
- A: "Generally, unless it's fast acting, either method will depend on your digestion." SH

The Community Engagement Team (CET) is a multi-agency collaborative and a program of the City of Cambridge Department of Human Service Programs. This spring, CET is offering the Making Connections training program, a free, in-person, seven-session outreach and engagement training program that emphasizes core skills necessary to effectively engage community members.

This program brings together service providers who are interested in strengthening their community engagement practices while also networking and learning about other programs and resources across the city. Making Connections is designed for providers who interact with the public. This may include: school-based family liaisons, public safety personnel, community health workers, public health outreach volunteers, youth advocacy and leadership teams, and other staff who engage the public.

Participants must be able to attend all 7 sessions on April 23, April 24, April 25, April 30, May 1, May 7 and May 8.
